

**Pre-Tender Site Visit:** Bidders are requested to visit the site at Kollam Co-operative Spinning Mills Ltd, Karamcode P.O., Chathannoor, Kollam District, Kerala, to assess the actual conditions and requirements before submitting their tender. The site visit will help bidders to understand the scope of work, identify potential challenges, and provide a more accurate quote.

Bidders are requested to submit the tenders in the name of Managing Director, The Kollam Co-Op: Spinning Mills Ltd, Karamcode.P. O, Chathanoor, Kollam - 691 579 on or before 03/12/2025 4:00 PM and opens at 04-12-2025 10am



To participate in tender, the suppliers are to make Earnest Money Deposit (EMD) [Refundable] and tender form cost (non-refundable) as a single transaction as follows:

#### **RULES FOR REMITTING TENDER FEE & EMD:**

**TENDER FEE:** Rs.250/- to be remitted directly to the mills before collecting the tender. For those who collect the form through e-mail the payment will be made to the mills before submitting alternatively take separate DD in favour of the mills along with tender.


**EMD:** Rs.1000/- to be remitted directly to the mills before collecting the tender. For those who submit tenders through speed post/registered post, separate DD in favour of the mills along with tender.

The prospective bidders (venders/ suppliers) may contact our office (Ph: +91-8590711057) for clarification on details of payment and submission of tenders.

**Rate for Work:** Bidder rate must be firm throughout the period of the contract and there shall be no upward revision of rates quoted by the bidder for any reason what so ever. However, GST or any other taxes will be as applicable at the time of billing.

#### **Terms and Conditions are as follows:**

1. The bidder shall carefully and thoroughly study and obtain all clarification on relevant details regarding prices and provisions necessary for successfully carrying and obtain all clarification on account of carrying out the supply as per the tender documents. No claim/ objections will be entertained at a later date on account of lack of clarity/misrepresentation of any data. The bidders are expected to work as per the specifications, terms and conditions of NIT.
2. Quantity may increase or decrease as per site conditions. However, billing shall be made on pro-rate basis. (The rate shall be quoted for running meter and the length of cables and piping, measured under running meter and the rate inclusive only mentioned items and extra claim shall not be entertained.
3. Bidders are required to quote only for the items as mentioned in the Notice Inviting Tender (NIT).
4. So please enclose the proof along with the submission of tender documents.
5. All taxes will be applicable as per the norms.
6. Bidders are required to their quote for tenders invited in a single cover, containing the following.
  - a. Price bid showing rates against each item.
  - b. Technical specification against each item
  - c. Proof of EMD and Tender form cost.
  - d. Specify whether excluding taxes.
7. KCSM shall have no responsibility for any technical issue/ delays from the bidders end or for non-receipt of tenders send through post/ or any other means.
8. The contract will be awarded to the bidder whose bid is the lowest (L1), at the negotiated rate, subject to the condition that the price is comparable with market price and bidder has the capacity and resources to carry out the contract effectively and timely.
9. Erection and commissioning of the above equipment's should be provided by the awarded bidder with experienced engineers at mill site within the shortest period.
10. Quotations are not properly filled, or with incorrect calculations and generally not complied with conditions, will summarily be rejected.
11. "Specification" shall mean all technical specification of the product/items/equipment.
12. KCSM does not bind itself to accept the lowest tender if any do not agree the terms and conditions of payment and completion period.
13. KCSM reserves itself the authority to reject any or all quotations received by assigning the reasons therefore.
14. The EMD of the unsuccessful bidders will be returned by the mills after completing tender formalities.
15. The quotation shall remain valid for acceptance for a period of 90 days from the date of submission.



16. The bidder must be an OEM, authorized dealer, or system integrator of reputed CCTV brands (such as CP Plus, Honeywell, etc.).
17. Should have completed at least one similar CCTV project for any Government / PSU / Industrial organization within the last three years.
18. Must possess valid GST registration and PAN.
19. Should submit a self-declaration of non-blacklisting from any Government institution.

**A. 4. Scope of Work**

1. Supply, installation, testing, and commissioning of an IP-based CCTV Surveillance System across key locations in the mill premises.
2. New cameras and components shall be supplied as per the technical specifications listed above.
3. The system shall provide continuous 24x7 recording, with 30-day storage capacity and remote/mobile viewing capability.
4. The vendor shall provide onsite demonstration and basic operational training for mill staff.
5. All equipment must be new, branded, and of industrial grade, and installation shall include all accessories, cabling, conduits, power components, and mounting hardware necessary for full operation.

**B. 6. Warranty and Maintenance**

All components shall carry a minimum 24-month comprehensive warranty. Free onsite technical support is mandatory during this period. Post-warranty AMC may be entered as per Kerala Stores Purchase norms.

**C. Payment Condition:**

10% advance payment will be released on the date of acceptance of the Purchase Order. 80% of the amount will be paid upon delivery and installation of the equipment at the mill site. The remaining 10% will be retained for a period of one year from the date of commissioning
