1. Service agency should have authorized service center within South India.
2. Proof of prior experience in similar works should be submitted.
3. Quotations must be submitted in a sealed cover addressed to the Managing Director, The Kollam Co-op: Spinning Mills Ltd, Karamkodu P.O, Chathannoor, Kollam – 691 579.
4. The quotation should clearly mention the tender reference number, item-wise cost, GST, and total value.
5. The entire work should be completed within scheduled day from the date of work order.
6. Serviced components/service should carry a minimum warranty of 6 month from the date of completion.
7. The tender shall remain valid for 60 days from the date of submission.
8. The contract will be awarded to the L1 bidder at the negotiated rate, provided the price is reasonable and comparable to market rates.
